A 50% deposit will be required before we action the order. The balance will be payable on the day of shipping.

#### Process

Once we received your order we will contact you for further arrangements.

A proof of your chosen label amended to reflect your colour choice and logo of your company will be provided to you for sign-off before printing.

Orders have to be placed at least 3 weeks before the Corporate event to ensure that you receive it in time.

#### General Terms & Conditions

##### 1. Detailed description of goods and/services:
